Device Description

mPRO is a software-based medication reminder application designed to provide alerts to patients for pre-determined medication dosing schedules through mobile device notification systems and provide a means for patients to record symptoms and disease activity.

Intended Use

mPRO is intended to provide medication reminders to patients to support adherence to prescribed medication schedules and to allow patients to record symptoms and disease activity. The device incorporates wireless communication through mobile operating systems to deliver notifications.

Indications for Use

- For use by patients with serious disease who require assistance in maintaining adherence to prescribed medication schedules.
- For use in the home or community setting.
- Compatible with standard mobile operating systems.

Warnings

- mPRO is an assistive tool only and does not replace medical judgment.
- mPRO is not a medical service. No doctor/patient relationship exists between GreenCape and users of mPRO.
- Users must consult their healthcare providers regarding their specific medication schedules.

- Internet connectivity required for full functionality

Operating Instructions

1. Download mPRO from authorized application stores.
2. Complete user registration.
3. Enter medication schedule as prescribed by healthcare provider.
4. Enable notifications when prompted.
5. Verify reminder settings.
6. Respond to medication reminders as they appear.

Technical Requirements

- Compatible with iOS and Android operating systems.
- Requires internet connectivity for setup and synchronization.
- Requires storage space on mobile device.

Maintenance

- Regular application updates required.
- Periodic verification of notification settings recommended.
- Review and update medication schedules as prescribed by healthcare provider.

Troubleshooting

If notifications are not received:

1. Check device notification settings.
2. Verify internet connectivity.
3. Ensure application is running in background.
